





Who Inspects your fire doors?

The Regulatory Reform Fire Safety Order 2005 (RRO 2005) came into force in England and Wales; transferring the responsibility for Fire Safety from the fire authorities to whoever has day-to-day control of the building premises e.g. an employer, owner, landlord, or occupier of a business or non-domestic premises. This is known as the Responsible Person.

The Responsible Person must:

- Take steps to reduce the risk from fire;
- Consider how to contain a fire should one break out;
- Ensure people can escape safely;
- Ensure that all your passive and active fire protection is under a suitable and sufficient programme of inspection and maintenance
- Identify a Competent Person i.e. knowledgeable, qualified professional to be able to implement fire safety measures in a building, such as Fire Door Inspections

On 29th April 2021 the Fire Safety Act 2021 received royal assent and was made into law.

The Fire Safety Act amended the RRO 2005 to replace the 18m rule for residential buildings with buildings where two or more sets of domestic premises are contained. In these buildings all fire doors including flat entrance doors and all common parts such as stairwells, cross corridor doors, store cupboards and risers should be checked.

Legislation dictates that Fire Doors should be checked every 6 months.

If you have been designated the "responsible person" for a building, it is your duty to ensure your Fire Doors are working effectively and to protect occupants in your building from the risk of smoke and fire.

Fire Doors are a crucial part of any public, commercial or multipleoccupancy buildings protection strategy and are essential to ensure that occupants can evacuate a burning building swiftly and safely; avoiding potentially tragic consequences. They resist fire and smoke and are probably the single most important element in giving occupants time to safely evacuate the building, but only if they work properly.

Its correct specification, fitting and maintenance are the responsibility of every person involved in the process. If short cuts have been taken to save money on specification or maintenance **Trusted Fire**Inspections are here to help you!



How do you know if your fire doors are safe?

• If you are the Responsible Person, you must make sure that the fire risk assessment is carried out. You can appoint a Competent Person* to do the actual assessment, but you are still responsible in law.

*If the Competent Person is an employee, the Responsible Person must ensure that appropriate and sufficient training is provided so that the fire safety obligations can be competently discharged. If the Competent Person is a contractor, it is implicit that the contractor must be able to demonstrate appropriate levels of competence, for example by third party assessment.

So how confident are you or your appointee in checking the fire doors and all the components fitted to them in your building? Do you know what to look for, or what to do if the doors or any of their components require maintenance?

Why should your fire doors be inspected professionally?

- Fire doors are an essential part of a building's Passive Fire Protection, ensuring that the building is compartmentalised and helping to prevent the fire from spreading, allowing any occupants time to escape.
- Fire doors act as any other door in normal service, but in a fire, they take on a critical role – to save lives and to protect property.
- The condition of fire doors and their components is included as part of the
 fire risk assessment. Building owners who fail to comply with the regulations
 can be prosecuted and fined or even sent to jail. Recent prosecutions have
 been severe, even for seemingly trivial issues such as failing to fit fire seals or
 closers or wedging a fire door open.
